4. Report from Technical Advisory Committee (TAC) Chair

The Chair recognized Mr. Chad McKeown, CAMPO Deputy Executive Director who provided a report of the discussion and action items from the March 28, 2022 TAC Meeting in absence of TAC Chair, Ms. Laurie Moyer, P.E.

Mr. McKeown reported that the TAC discussed federal performance measure target updates and unanimously voted for a recommendation to adopt the 2022 Performance Measure Report and target updates.

The TAC also received a presentation on the draft 2023-2026 Transportation Improvement Program (TIP), SmartTrack Initiative from the TxDOT-Austin District, and a Regional Transportation Demand Management (TDM) Subcommittee Update from its Chair and TAC Vice Chair, Gary Hudder.

5. Presentation and Public Hearing on the Draft 2023-2026 Transportation Improvement Program (TIP)

The Chair opened the public hearing and recognized Mr. Ryan Collins, CAMPO Short-Range Planning Manager who provided an overview of the draft 2023-2026 TIP, and its functions. Mr. Collins informed the Board that the 2023-2026 TIP includes approximately \$6 million in funded projects and added that it is the largest TIP to date. Mr. Collins highlighted individual project listings for Highway, Transit, specific and group projects, and additional listings. The 2023-2026 TIP development schedule was also presented.

The Chair recognized Ms. Doise Miers, CAMPO Public Outreach Manager who provided a brief overview of the public involvement process for the draft 2023-2026 TIP. Ms. Miers presented a schedule for public meetings and 1 (one) on-line open house and briefly discussed options to submit public comments. Ms. Miers also presented and briefly discussed CAMPO's new curb-side option to submit in-person public comments. The public hearing closed without public comments offered.
