Projects selected by the Transportation Policy Board will be programmed with federal funding currently apportioned to the region or forecast to be apportioned in future fiscal years. These amounts are estimates and not guaranteed beyond the current federal transportation bill, the Infrastructure and Investments in Jobs Act (IIJA), which is currently authorized through Fiscal Year 2026. This forecast assumes the continued authorization of the federal programs and current apportionment levels. Funding amounts shown are for the federal funding share only and do not include the required local share.

CAMPO may recommend additional funding above these amounts as determined by the scheduling of projects submitted, progress of currently funded projects, and additional funding availability.
